Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below at 12:00 pm Cairo time on Monday, May 15, 2023.
- 8. Specific Construction & Contract Management Experience: A minimum number of (1) one similar contract or (2) two specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, between 1st January 2018 and bid submission deadline. At least one similar contract of minimum value of USD14 million or two contracts of minimum value USD8 million. The similarity of the contracts shall be industrial infrastructure and/ or industrial township contracts that are comparable in terms of physical size, complexity, components, activities, construction method, technology and/or other characteristics.
- 9. All Bids must be accompanied by a Bid Security of USD 240,000 or equivalent in EGP valid for a period of 148 days from the Bid submission date.
